High Pressure Fire Water System Dry Pipe Hybrid Conversion - \$2,163,236.10 and Isolations (C-331, C-335, C-310, and C-315 Facilities)

As the prime contractor, Ma-Chis International Services subcontracted Premier Fire & Security to perform modifications to 34 Wet-pipe High Pressure Fire Water systems (HPFW) in the C-331 facility, 37 Wet-pipe HPFW systems in the C-335 facility, 3 HPFW riser isolations in C-310 facility, and 1 HPFW isolation in the C-315 facility at the Paducah Gaseous Diffusion Plant (PGDP) site near Paducah, Kentucky. The achieved goal was to modify the existing Wet-pipe systems to a dry-pipe hybrid type system that is pressurized with air, applying alarm only function (i.e., system dry and manual introduction of water when needed) upon sprinkler activation. C-310 and C-315 HPFW Risers would only be isolated from the existing HPFW systems by means of blank flanges and/or plugs where entering the facilities and would not have dry hybrid modifications performed on these risers. Upon completion of the project Ma-Chis/Premier Fire & Security were "Highly Recommended" by FRNP Site Management to other DOE/NSA sites due to project management and communication performance.
